ORDINANCE NO. 2021-61: AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH GRIPCO PRODUCTS, INC. DBA GPI DESIGN AND L7 GROUP, LLC FOR THE PROVISION OF INCENTIVES AVAILABLE PURSUANT TO CHAPTER 3735 OF THE OHIO REVISED CODE FOR THE CONSTRUCTION OF A NEW 20,000 SF BUILDING WITHIN THE COMMUNITY REINVESTMENT AREA, AND DECLARING AN EMERGENCY. **- Adopted**
