- ORDINANCE NO. 2021-98: AN ORDINANCE RATIFYING ACCEPTANCE OF THE ONEOHIO OPIOID SETTLEMENT WITH OPIOID DISTRIBUTORS AMERISOURCEBERGEN, MCKESSON AND CARDINAL HEALTH, AND DECLARING AN EMERGENCY. **- Adopted**
- ORDINANCE NO. 2021-99: AN ORDINANCE ACCEPTING A BID AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH MR. EXCAVATOR FOR CLAGUE PARK PLAYGROUND IMPROVEMENTS, AND DECLARING AN EMERGENCY. **- Amended, adopted**
- ORDINANCE NO. 2021-100: AN ORDINANCE AUTHORIZING THE MAYOR TO PARTICIPATE IN THE OHIO DEPARTMENT OF TRANSPORTATION'S BID FOR SODIUM CHLORIDE IN ACCORDANCE WITH SECTION 5513.01(B) OF THE OHIO REVISED CODE, AND DECLARING AN EMERGENCY. **- Adopted**
- RESOLUTION NO. 2021-101: A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY FISCAL OFFICER. **- Adopted**
