



**WESTLAKE BOARD OF ZONING APPEALS
PUBLIC HEARING SCHEDULE – Year 2019**

The following is a list of tentative dates for the Board of Zoning Appeals Public Hearings in 2019 and are subject to change. The public hearings are generally the last Tuesday of each month at 7:30 p.m. The BZA does not meet if there is no new business before the board. All public hearing agendas, dates and times are posted at City Hall prior to the public hearing. Public hearings are held in Council Chambers, 27700 Hilliard Blvd. unless noted otherwise.

Building and engineering permit requests must be reviewed by the building or engineering department prior to the 5:00 p.m. BZA deadline so plans must be submitted to the those departments at least five business days prior to the BZA deadline so they can review the plans, deny the permit, and determine what variances are necessary. Final BZA application must be made to the Clerk of Commission no later than 5:00 p.m. deadline date.
